Notice the regulations for import: Rabies vaccination must be taken no later than 21 days before import date. Show pens will be numbered and it is not allowed to change the place without show manager's approval. Pen size 65x65x55 cm. If you bring your own show shelter, please inform it upon entries. Minimum size for own show shelters is 50x50x50cm. Show pen placement requests preferably through Omakissa or by email [pj.porok@gmail.com](mailto:pj.porok@gmail.com). Owners may present their cats to the judges.

E-mail entries: form must be filled for each show, receipt of payment shall be attached.

Number of cats entered is limited to 320 per show. Date of the paid entry is the basis for elimination from the show in case maximum cat number is exceeded.
